- Rural City AA** 1st teams of the 10 AA centres as indicated in Regulation D, 60. b).
  - Rural City A** 2nd teams of the 10 AA centres as indicated in Regulation D, 60. b).
  - Rural AA** Category open to Bantam division only for approved teams with players from a maximum of five associations within one region. Prior to tryouts, the five associations must be declared. Amalgamated associations will be considered as one association if in existence for three consecutive years.
  - Rural A** 1st teams of centres with an enrolment of 116+ players in the male program (Novice-Midget) of their association or amalgamation in the current season.
  - Rural B** 1st teams of centres with an enrolment of 76-115 players in the male program (Novice-Midget) of their association or amalgamation in the current season.
  - Rural C** 1st teams of centres with an enrolment of 51-75 players in the male program (Novice-Midget) of their association or amalgamation in the current season.
  - Rural D** 1st teams of centres with an enrolment of 0-50 players in the male program (Novice-Midget) of their association or amalgamation in the current season.

1. Each minor association will fill out applications for all teams entering provincials and forward them to their Zone Registrar (on or before December 15<sup>th</sup>).
2. Registrar is to review applications with the approved roster to ensure that each team is placed within their correct category based upon the regulations.
3. **Male Teams** - All teams shall enter the category of play as determined by Regulation D, 54. Teams are not permitted to move down and must compete in their respective category as determined above. (Teams may request to move up)
4. **Female Teams** - Teams will be placed in categories at their regional meetings and are subject to review by the regional female Vice Directors prior to the Semi Annual meeting. Regions are required to supply their teams' standings within the leagues they participate in. This information, as well as the teams' official rosters are to be provided to the regional female Vice Directors prior to the Semi Annual meeting. (Please see Hockey Manitoba website for female categories that will be held this season)
5. The branch office will compile all regional information for review and ratification at the Semi-Annual Meeting.

**NOTE:** Any team withdrawing from Provincials within 7 days following the Hockey Manitoba Semi-Annual meeting, excluding exceptions, shall be fined \$500.00. Any team withdrawing from Provincials after 7 days following the Hockey Manitoba Semi-Annual meeting, excluding exceptions, shall be fined \$2,500.00. The team's Minor Hockey Association shall be responsible for collecting all fines and submitting them to Hockey Manitoba.
